- Post-entries will be accepted up to 30 minutes before the beginning of the show on Sunday, May 18.
- Entries postmarked after May 1, 2025, will be charged at the late fee rate
- All horses must have Negative Coggins within 12 months and a health certificate within 30 days.

Cruelty, abuse, or inhumane treatment of any horse in the show ring, barn, stalls, or on the grounds is strictly prohibited. The use of stimulants, depressants, or any drug affecting the showing of a horse is forbidden.
